MULTI-TASKING STAFF (CATEGORY-I) – (Drivers)**

NIPHM invited applications for filling up 3 posts of MTS (Category-I) for driving purpose {2 (UR) & 1(OBC) posts} on direct recruitment basis. The post is advertised in the Pay Band-1 of Rs. 5,200-20,200 + GP RS. 1800/- with the following conditions.

Multi-Tasking Staff(Category-I) – 03 posts 2 (UR) 1(OBC)	Direct recruitment

A total of 414 applications are received for 3 posts of MTS (Category-I). Presently NIPHM possess six vehicles (1 bus & 5 light motor vehicles) and two more mini buses i.e., Swaraj Mazda procurement is in process of purchase. Only 3 regular drivers are available and unable to provide transport services effectively to the Officers, participants and dignitaries. All the requirement of MTS – I were projected to perform driving functions only. In view of this the committee proposes to call candidates having Heavy Motor Vehicle driving licence in Phase I for further process of selection i.e., of skill test and written test in view of the immediate office requirement .
