- 2. Tenderer should deposit Rs NIL Rupees NIL Only) towards Earnest Money (refundable) in the form of demand draft drawn in favour of NIPHM, Hyderabad payable at Hyderabad.
- 3. Please quote the rates for free delivery at NIPHM, Rajendranagar, Hyderabad-30 and no other charges such as Octroi, packing, forwarding, insurance and loading, unloading, freight and clearance etc., will be allowed by the institute.
- 4. The VAT/Sales/General taxes where legally leviable and intended to be claimed should be distinctly shown along with the price quoted. Where this not done no claim for VAT/Sales/General taxes will be admitted at any stage and on any ground what so ever. VAT/CST registration No. and date of its validity should be indicated. This Institute will not provide "C" & "D" forms, hence quote for the taxes actually leviable.
