HOW SAFE ARE YOUR VEGGIES PROJECT

November, 2019

Twenty **Beans samples** were collected randomly in the month of November, 2019 from the market in the area of Mehdipatnam.

The samples were analysed for pesticide residues using validated method with confirmatory analysis on GC-MS/MS and LC-MS/MS at 10 PPB (Parts per Billion) level.

Total Twenty (20) samples analysed and twelve samples found contaminated with seven (Carbendazim, Acetamiprid, Triazophos, Acephate, Pretilachlor, Bifenthrin and Fenpropathrin) pesticide residues (Table-1). No samples are found with pesticide above FSSAI MRLs.
