HOW SAFE ARE YOUR VEGGIES PROJECT

January, 2020

Twenty **vegetable (Indian beans and Cluster beans) samples** were collected randomly in the month of January, 2020 from the market in the area of Mehdipatnam.

The samples were analysed for pesticide residues using validated method with confirmatory analysis on GC-MS/MS and LC-MS/MS at 10 ppb (Parts per Billion) level.

Total Twenty (20) samples analysed and sixteen samples found contaminated with two pesticide residues (Table-1). No samples are found with pesticide above FSSAI MRLs.
