NIPHM will not be held responsible to give regular appointment after expiry of the term. No TA/DA will be admissible for attending the interview.

	Coordination of training programs & communications.
	• Assisting in off-campus trainings and visits during establishment of bio-input centres in different states.
	• Assist in practical sessions and demonstrations during training programs for officers / students / farmers
	• Support in outreach activities of the institute in villages / out station
	• Maintain records, data and reports on trainings etc.

GENERAL TERMS AND CONDITIONS:

- 1. The position of Young Professional is purely on contractual basis for a period of <u>Six months/ Project</u> <u>Period</u> whichever is earlier.
- 2. The continuance of Young Professional during the said period of six months depends on the satisfactory performance and availability of the budget for the project in which they have been engaged. It can be terminated at any time by issue of one month notice by NIPHM. It can also be terminated at any time without giving one month's notice if he/she is found guilty of gross negligence or involved in acts of grave misconduct. The services shall stand terminated automatically on expiry of the *contract* period unless it is extended in writing.
- 3. The candidates have to produce all the original certificates / documents at the time of Interview for verification. Failure to bring the same will render ineligible to attend Interview.
- 4. No TA/DA will be admissible for attending the interview.
- 5. Self-attested copies of all educational qualifications along with experience certificates are required to be submitted invariably.
- 6. Age and educational qualifications may be relaxed in exceptional cases by the Institute.
- 7. Candidates may submit a declaration stating that they are willing to be considered for a lower position in case their application for the applied position is found ineligible or if not been shortlisted for a further scrutiny.
- 8. In respect of Young Professional-I, an amount equivalent to one month pay will be deducted in four equal installments i.e. @1/4th pay per month from first four months remuneration as caution deposit. This amount will be refunded to the candidate only on successful completion of notice period obligations. The decision of the Competent Authority will be final in this regard.
- 9. The Young Professional may also leave the assignment, on their own violation by giving one month notice period / deposit 30 days' pay in lieu of notice period or any short fall thereof or as decided by the Competent Authority of NIPHM. The decision of the Competent Authority will be final in this regard.

If any of the contractual staff leaves NIPHM abruptly or without serving notice period, the caution deposit amount available will be withheld/forfeited/confiscated. The decision of the Competent Authority will be final in this regard.

10. If Young Professional undergo any training programme at NIPHM either free or on concessional basis, he/she shall serve the NIPHM for a minimum of two years, failing which he/she shall reimburse the cost of the training programme to the NIPHM at the time of getting relieved. However, no request will be considered for exemption of fees if anyone wants to leave the institute before completion of Bond Period. The certificate of participation will be on hold of the institute for two years after completion of the training.

- 11. The Young Professional is required to adhere to the administrative, financial and disciplinary regulations of NIPHM where the incumbent is working. Regular attendance of them shall be ensured by the concerned Director of the division keeping an attendance register/ biometric.
- 12. The Young Professional shall be engaged in the Scheme/Project work on full time basis and will not be allowed to undertake any other work or to accept or hold another appointment with or without remuneration elsewhere.
- 13. The Young Professional shall give a declaration to the effect that he/she is not drawing any other scholarship/fellowship or is employed elsewhere in the form prescribed.
- 14. NIPHM will have full intellectual property rights/proprietary rights on research outputs of the SRFs/Young Professional with reference to work done during the period of working in the NIPHM as per the provisions of "Guidelines for Intellectual Property Management and Technology Transfer / Commercialization" *mutatis mutandis*. However, in case the Young Professional/RAs/SRFs/JRFs has been associated with research work, his/her name will be acknowledged / included appropriately in the research paper(s). The Young Professional shall have no right in this regard.
- 15. The Young Professional will be under the administrative control of the Director of the concerned Division at NIPHM. The Young Professional will be subject to the Administrative, financial and disciplinary regulations of the NIPHM. Young Professional shall have to work on all working days except for the General holidays and adhere to punctuality in attendance and should be willing to work before & after office hours in case of need. He/ She should be willing to work late hours, night shifts/ on holidays etc. as & when ordered by competent authority as per the requirement of the institute's work.
- 16. Their headquarters will be at Hyderabad (OR) will be as necessitated by the project.
- 17. The Young Professional will not be entitled to (i) General Provident Fund, (ii) NIPHM Group Insurance Scheme, (iii) All other service benefits allowed to regular employees. He/She will not be entitled to any travelling allowance at the time of joining and leaving NIPHM.
- 18. The Young Professional will be entitled to admissible tour TA & DA as per NIPHM rules.
- 19. Income tax will be deducted from the emoluments of Consultants SRFs/Young Professional at source as applicable.
- 20. Young Professional shall stay within 03 kms radius of NIPHM
- 21. The Young Professional is required to produce all the original certificates of educational qualifications, experience at the time of joining at NIPHM for verification.
- 22. Young Professional will not be entitled to any Medical benefit & allowances.
- 23. The Young Professional shall have no claim, whatsoever, for regularization/absorption or otherwise against any regular post on termination of the tenure/project as it is purely contractual/temporary & is time bound in nature which runs co-terminus with the length of the project.
- 24. No correspondence will be entertained with the non-shortlisted or non-selected candidates.
