National Institute of Plant Health Management (NIPHM), Hyderabad is organizing an exclusive training on "Phytosanitary Inspection training for Phytosanitary Service Agency and Phytosanitary Service Provider (PSSA&PSSP) for Inspection of Plants/Plant Products & Other Regulated Articles in Export" from 01-07-2024 to 30-07-2024 to impart training as per *NSPM-23* Guidelines. This training will enable the phytosanitary inspector to acquire technical skills and competency to perform phytosanitary inspection for export consignments of plants/plant products and other regulated articles meeting the phytosanitary requirements of importing country and thereby fulfilling the International obligations under the International Plant Protection Convention (IPPC) and World Trade Organization-Sanitary and Phytosanitary Agreement (WTO-SPS).

Age limit: The Entry age - not more than 45 years

Educational Qualifications: Master degree in Agriculture/Zoology/ Botany/ Plant Protection with specialization in Entomology or Plant Pathology or Nematology or Weed Science or Agronomy (as per NSPM -23).

Venue: NIPHM, Hyderabad

Course fee: Rs.35,400/- (Rs.30,000/- + 18% GST)
