Eligible participants

Govt. officials/Technical Officers, Scientists/Assistant Professors or above, from any university/institute/organization. The CEOs of FPOs/SHGs., rural youth entrepreneurs who are practicing natural farming.

Guidelines for government officials:

- There will be no training fees for government officials.
- However, TA/DA will not be provided to participants by the institute and boarding charges have to be borne by the participants@Rs.305/- per day/participant directly to the service provider. Further, free lodging will be provided at NIPHM for the training period, only. Additional days of stay will be charged as per the NIPHM norms. No family member is allowed even on a payment basis.

- Govt officials must upload their nomination letters & official nomination may be communicated to this institute through proper channels.
