Training program on "Fumigation as a Phytosanitary Treatment (Methyl Bromide and Aluminium Phosphide Fumigation)" at NIPHM Campus, Hyderabad

The trade in food grains, seeds, plants for propagation and various wood packaging materials are the primary pathways for global spread of plant pests. Fumigation is one of the approved Phytosanitary treatments to facilitate import and export of agricultural commodities. National Institute of Plant Health Management (NIPHM) is a notified Institute for organizing 15 days training programme on Phytosanitary Treatments (Methyl Bromide and Aluminium Phosphide fumigation). The training program on "Fumigation as a Phytosanitary Treatment (Methyl Bromide and Aluminium Phosphide Fumigation)" will be organised in several batches at NIPHM Campus, Hyderabad.

As per NSPM 12 & 22, the eligible operators shall be required to undergo the above training for the accreditation of Fumigation Agencies for undertaking Methyl bromide and Aluminium Phosphide Fumigation. Further, treatment provider agencies and their operators who are interested in revoking their suspension shall also attend this programme. This training programme is structured to impart technical skills and competency in performance of effective fumigation operations with Methyl bromide and Aluminium Phosphide. The training programme includes in-house theory classes followed by exercises and practical sessions on fumigation activities.

Eligibility:

Applicant should be a graduate in B. Sc. Degree in Agriculture or B.Sc. Degree with Chemistry as one of the subject from any recognized University (as per NSPM 12 section 2.1 (Eligibility &Section 2.1.1)). Graduates in the mentioned subject who are interested to take-up fumigation activities may apply. The course to be organised by this Institute will have limited intake and the candidates have to register themselves in NIPHM website on or before 15th April 2021 (for first batch).

Course fee, lodging & boarding charges:

Course fee: Rs29,500/- (Rs.25,000/- per person+ GST 18%). Single Room: Total charges for 15 days: Rs. 16,290/- (Rs. 1086 x 15 days) (Rs.775 (Room tariff) + Rs. 311 (Boarding charges) = Rs.1086/- per day) Sharing Room (twin occupancy): Total charges for 15 days: Rs. 11,415/- (Rs. 761 x 15 days) (*Rs.450 (Room tariff)* + *Rs. 311 (Boarding charges)* = *Rs.761/- per day*)

(Note: 1. An additional amount of Rs. 109/- per day will have to be paid by the candidate towards boarding charges under quarantine conditions, if any. 2. The allotment of rooms shall be as per the availability and the amount shall be adjusted accordingly, if paid).

Application procedure: Interested candidates may register on the NIPHM website <u>http://niphm.gov.in</u> and, upload their photo (jpg format – 50 kb max) and educational certificates (only degree certificate and marks sheet) as a single pdf file with maximum size limit of 2MB. After receiving the approval from NIPHM along with the User ID and Password, the candidate shall pay the course fee and lodging & boarding charges (if required) and enter the transaction details in (NIPHM) website using the given User ID and Password. After the due verification of the amount paid, the candidate shall be provisionally admitted and, finally intimated to attend the programme. The candidate appearing for the programme must bring the copies of certificates attested by Gazetted officer and submit them on the first day of the programme.

Mode of payment: Payment towards course fees and lodging & boarding charges can be made through online in NIPHM account, which shall be shared on shortlisting the application.

If more nominations are received, NIPHM reserves the right to organize the training in different batches during different periods based on the availability of accommodation and training slots at NIPHM. Candidates who had earlier shown interest in this course shall also be given due preference while shortlisting the nominations in the upcoming batches since this course is planned based on demand from all the stakeholders. All the eligible candidates who require training will be trained in a phased manner.
