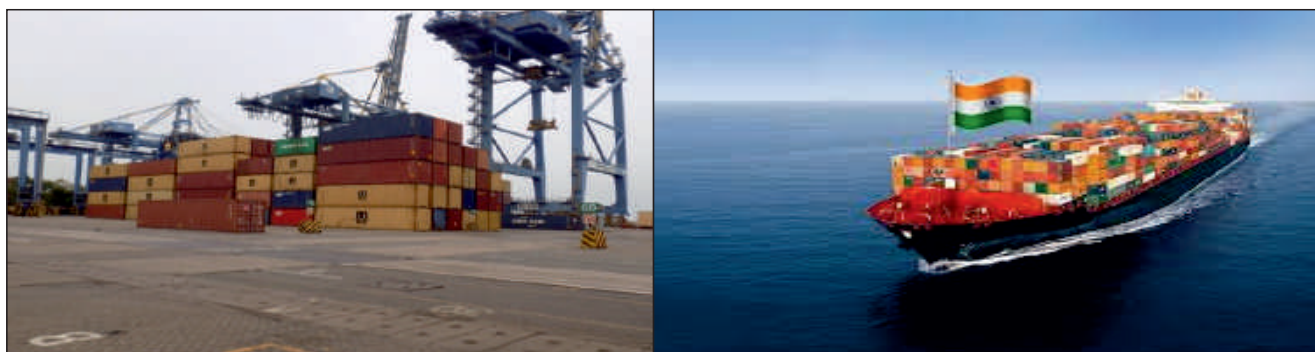

About a free webinar:

The Food and Agriculture Organization of the United Nations (FAO) estimates that up to 40% of food crops are lost to plant pests and diseases annually. This leaves millions of people without enough food to eat and seriously damages agriculture – the primary source of income for poor rural communities.



The current COVID-19 outbreak experience highlights the need to ensure that plants are protected from the ravages of plant pests. Therefore, ensuring safe supply of fresh food and protecting plants from pests is now more important than ever. Hence, The United Nations has declared 2020 as the International Year of Plant Health (IYPH). The main focus is to prevent the plant pest and diseases because they have the greatest impact on our crop, on our environment and our way of life.

Plant health is a global issue. The recent incursion of many invasive pests such as tomato pin worm (*Tuta absoluta*), rugose spiralling whitefly (*Aleurodicus rugioperculatus*), fall army worm (*Spodoptera frugiperda*) and Bondar's nestling whitefly (*Paraleyrodes bondari*) make huge loss to farmers in terms of crop loss. The exponential expansion of trade in agricultural material and the speed at which the agricultural products are moving around the globe, coupled with the removal of trade restrictions in post-WTO era, the chance of pests, diseases and harmful organisms to move to hitherto unrecorded areas are high. There is an urgent need to protect the biosecurity of a nation from the bio-invaders to sustain food security and preserve biodiversity.



The International Year of Plant Health (IYPH) 2020, FAO and the International Plant Protection Convention (IPPC) are working to protect plant health worldwide. National Institute of Plant Health, Rajendranagar, is very proud to celebrate International Year of Plant Health.
